MINUTES OF THE COMMITTEE OF THE WHOLE MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES MONDAY, JANUARY 5, 2015

CALL TO ORDER AND ROLL CALL

Trustee Schiestel called the meeting to order at 6:36 p.m. in the Municipal Center. Present at roll call were President Nunamaker, Trustees Anderson, Blohm, Colletti, Knar, Migdal and Schiestel. Also present were Administrator Soderholm, Chief Lukasik, Management Assistant Bechler, and Deputy Village Clerk Majkrzak.

VILLAGE PRESIDENT & BOARD REPORTS

1. APPROVAL OF MINUTES

Trustee Blohm made a motion to approve the minutes of the December 18, 2014 Committee of the Whole and December 18, 2014 Executive Session. Trustee Migdal seconded. Roll Call: Trustees Anderson, Blohm, Colletti, Knar, Migdal and Schiestel – all “yes”. MOTION PASSED.

2. DISCUSSION: GOLF CART ORDINANCE

Staff presented an ordinance that is a compilation of the State laws, ordinances from other municipalities and requirements requested by the Trustees. Discussion held: prohibited from driving on State highways so can only cross at Lincoln; vehicle sticker fee, an exemption for Village employee use during special events, add language referring to parking ordinance, lower driving age from 21 to those holding valid driver’s license. It was suggested to hand out a sheet listing requirements, parking restrictions. Trustee Schiestel made a motion to send to the Village Board the ordinance relating to golf carts pending changes discussed: fee to \$10, age down to 16, parking restrictions, municipal exemption for Village events and include language to allow use on Lexington to Lincoln. Trustee Colletti seconded. Roll Call: Trustees Anderson, Colletti, Knar, Migdal and Schiestel – “yes”. Trustee Blohm – “no”. MOTION PASSED.

OTHER BUSINESS

Trustee Colletti asked about the dates for the MS4 permit (2018). Staff explained time schedule for permit.

ADJOURNMENT

Trustee Schiestel made a motion to adjourn the Committee of the Whole meeting at 6:57 p.m. Trustee Colletti seconded. All were in favor.
